Permission for Delivery of RaiseRight Cards and Waiver of Claim

I, _____ give permission to St. Elizabeth to deliver gift cards, which I have ordered from the parish or school to my child, _____ .

I understand that my child will be responsible for the safe transport of the gift cards from St. Elizabeth to my home and certify that I have discussed the responsibilities associated with the transport of the gift cards with my child. I further understand that I have the option of personally picking up my gift card order from the parish or school rather than having my child transport it.

I agree that the parish or school is not responsible for any gift card which is lost, stolen or misplaced. I hereby waive any right of recovery that I may have against the parish or school for the gift card which is lost, stolen or misplaced after my child signs for it and it is given to my child.

I understand that gift card orders of \$400 or more dollars should be picked up by and adult and should not be sent home with my child.

This agreement is effective for the 2022-2023 school year.

St. Elizabeth Gift Card
RAISERIGHT PROGRAM AGREEMENT
Program Year – April 1st through March 31st

St. Elizabeth (referred to herein as "we," "us" and "our") sponsors a RaiseRight program (referred to as St. E's Shoppe E's gift cards) which allows you to help reduce your tuition. The RaiseRight you purchase through our program generates rebates from the participating retailers.

These rebates can be used at the end of the academic school year as earned credit to your tuition account or tuition account for a school family(s) of your choice, and/or a contribution to the church or school. The parties agree as follows:

Rebates earned will be used in the following way: (select one)

- a. earned credit* for school family (ies): _____

- c. use earned credit for church

You agree to indemnify us against any loss incurred in connection with there being insufficient funds in your account to cover the check or ACH transfer you issue to pay for your RaiseRight. We make no representations or warranties of any kind with respect to RaiseRight. This agreement remains in effect for the program year unless terminated or revised by either party upon 60 days advance notice to the other. St. Elizabeth requires a minimum of 60 days notice for updates or other changes. St. Elizabeth reserves the right to require cash payments for RaiseRight purchases.

Our RaiseRight program distributes the earned credit once a year in the month of June. Any delinquent parish or school accounts or accounts with insufficient funds will not qualify for earned credit. **Earned credit will only be issued for RaiseRight accounts generating a minimum of \$25 net earned credit during the program year.*

By signing below you agree to allow distribution of any remaining earned credit funds to be distributed to benefit St. Elizabeth parish or school, if your student withdraws prior to or at the end of the program year. Students enrolling in diocesan high schools may credit those funds toward their student's diocesan high school account.
